# 1. ANNOUNCEMENT

The Jersey Motorcycle and Light Car Club, herein referred to as the Organisers, will promote a Closed Road Interclub stage rally on 11th & 12th October 2024, to be known as the "Roberts Garages Jersey Rally 2024". This event will form part of the JMC & LCC Drivers and Navigators Rally Championship, Registration no: CH2024/RALLY029 CONFIRM REG in accordance with their regulations. A trophy rally will be run on Saturday 12th October 2024 for competitors unable to complete Friday's stages. Further details may be found at the end of these supplementary regulations.

# 2. JURISDICTION

The event is held under the 2024 General Regulations of the Motor Sports UK. (Incorporating the provisions of the International Sporting Code of the FIA), and these Supplementary Regulations, the Final Instructions for the event, and any written instructions that the organisers may issue for the event.

Roads closed for the running of this event are closed in accordance with the provisions of an order made under Article 50 of the Road Works and Events (Jersey) Law 2016.

# 3. PERMIT

The Motorsport UK Permit Number is: 133500 and the Permit, together with the Bailiff of Jersey's Permit for the event will be displayed on the official notice board.

# 4. **ELIGIBILITY**

The event will be open to competitors (whether Entrant, Driver or Co-driver) holding a valid Motorsport UK Interclub or higher competition license, who are fully elected members of either JMC & LCC, Guernsey Kart & Motor Club, Guernsey Motorcycle & Car Club, or Guernsey Rally LBG or of clubs affiliated to the ASWMC & ACSMC.

The Jersey Rally will not accept any Hybrid or Electric vehicles.

All competitors must produce their licences and a valid club membership card at documentation.

Overseas membership is available to visiting crews, who are not a member of the above associations (ASWMC or ACSMC). Membership is valid until January 31<sup>st</sup>, 2025 at a cost of £20.00, upon completion of the online membership proposal forms from each crew member. Completed proposal forms must reach the Entries Secretary by the Closing Date.

All competing members are reminded that in order to enter the JMC & LCC Rally Drivers Championship and Rally Navigators Championship 2024 rounds, they must be JMC & LCC members.

All competition licences will be inspected at Signing-On. Please ensure that the licence has been signed before presenting at Signing-On.

# Sunday 13 October 2024

RJA&HS (Rally HQ) clearance exercise & hand back to landowner (by 11.00)

Please note that security will only be provided on Thursday 10th & Friday 11th October 2024 at the RJA & HS service ground, this will be for rally cars and service vehicles left on site after scrutineering and during Parc Ferme on the Friday. No security is provided on Saturday night.

The Friday evening stages will run into the hours of darkness, and competitors are reminded that auxiliary lights must not be used on non-competitive road sections of the event.

Vehicles must be presented at Scrutineering fitted with the lights to be used on the event, wired in accordance with the relevant Road Traffic Laws. Service time will be made available for lights to be fitted prior to the night stages.

Any competitor not having passed noise test, scrutineering and/or not having signed on by the time specified in the Final Instructions will not be permitted to start the event, and their place offered to any reserve.

Provisional results will be published as soon as practicable after the arrival of the last car into Parc Ferme on Friday evening in order to reseed competitors for Saturday morning. These results should also be available to view at <a href="https://www.rallies.info">www.rallies.info</a>.

The order of restart and MC restart times will be posted on the official notice board at the RJA&HS and alternatives may be used, such as Sportity, the rally website <a href="www.jerseyrally.com">www.jerseyrally.com</a> or the official Rally Facebook page. All official Bulletins appertaining to this event will be placed on the official notice board or any of the above sites and it will be the duty of the competitors to make themselves aware of the amendments/changes during the course of the event. Any amendment will require a signature from a member of the crew, and it is the responsibility of the competitors to ensure that they have correctly read the amendment.

The Sportity App may also be used to communicate up-to-date event information. This free app is available from Google Play and the App Store. Details of the password for the Roberts Garages Jersey Rally 2024 will be provided in due course.

# 6. MARSHALS

The Jersey Rally Committee and Competitors will be responsible for the supply of all marshals, timekeepers, radio officers, volunteers, officials needed for the Jersey Rally. Again, this year we will be

supported by 60 UK trained marshals for the duration of the event. Below are the minimum that are required from all Jersey resident crew members.

Each Jersey resident crew member will be asked to supply a minimum of 1 nominated person positions (2 voluntary commitments per car). Please see the commitments and entry form for all details. In 2024, the only method of contacting the Jersey Rally Chief Marshal will be via the following email address rallymarshal@jerseymotorsport.com. This will be strictly enforced. No other form of contact will be deemed permissible or acknowledged. Please note that your nominated persons may act in an official capacity but please do make this clear on your form (i.e. marshal/timekeeper/radio officer/other). Each nominated person must attain their 2024 Motorsport UK accredited Marshal Registration, and all local marshals must attend the marshals briefing at 7.30 pm Wednesday 9th October 2024. It is the competing crews' responsibility to ensure that their marshals attend this briefing. Overseas marshals will be briefed on Thursday at a venue and time to be advised.

At least 1 crew member must attend the marshals' signing on to be held on Wednesday 9th October 2024.

Crews whose marshals/nominated persons have not signed on or obtained accredited marshal may not be permitted to start the event.

Marshals/nominated persons MUST be 18 years of age or older.

Any competitor whose supplied marshals/nominated persons fail to carry out their duty, may have their results disqualified at the discretion of the clerk of the course. (G) 5.3.3.

Any competitor whose marshals/nominated persons are not in position on stage at the appointed time, will not be allowed to leave service until their marshal(s) are in position.

All marshals and nominated persons signed on must be able to understand and have a good command and knowledge of the English language.

Any crew that withdraws their entry after the closing date will receive a refund for those monies paid in line with the schedule in Article 9.12. Local crews will also have to continue to provide their required 2 marshals or nominated persons; the penalty for failing to do so will be the possibility of a refused entry in subsequent years.

# 7. CLASSES

# 7.1

Cars with forced induction will have their engine capacity increased as per (J) 5.4.1 to establish their class, Coefficient of 1:7.1

Cars with rotary engines will have their engine capacity increased as per (R) 48.2.4. To establish their class.

Should any class have less than 5 entries, the organisers reserve the right to amalgamate two or more classes or to reduce the awards list as deemed appropriate. Competitors will be amalgamated into classes A to E according to capacity of their vehicles.

All cars must comply with 2024 Motorsport UK Technical Regulations J5 and where appropriate to the F.I.A. Regulations.


All non-Jersey registered cars must be taxed and insured for the Public Highway along with a current. M.O.T certificate where applicable

Jersey registered cars must display a current windscreen insurance disc.

# 8. **IDENTIFICATION**

Competitors must make space available to the Organisers of the Event and the Promoters of the Series, on and above both front doors in the positions shown on the diagram below, for Event identification: H 28.1.1

- a. The Official Event Logo/title
- b. The vehicle competition number
- c. (c,d,d,e) Other advertising proposed by the event organisers/sponsors.



Competitors must display regulation size black numbers on a white background on both sides of the car and regulation size orange or yellow numbers placed on each rear side window (or equivalent area on smaller vehicles), in accordance with Motorsport UK Competition numbers J4.1, J4.1.1 & R6.1.3 b. R6.1.4. Competitors are reminded that these numbers **MUST** be removed after the event or upon retirement from the event.

# 8.1

Competitors will also be issued with the event rally plates (to be fixed to the front and rear of the car) and the small numbers to be affixed to the rear window.

#### 8.2

Competitors may be requested, but will not be obliged, to carry further advertisements in areas other than those specified in Article 8 a,b,c.

# 8.3

Competitors who do not provide the space required in article 8 a,b,c. above may be either refused a start or disqualified from the results as appropriate to the case. Article 20.3 and 20.4

# 9. ENTRIES / FEES

The Entry Fee is £900, this includes Motorsport UK insurance fees, Service Pack and a £30 contribution to the Jersey Motor Cycle and Light Car Club Environmental Fund in order to offset carbon emissions by supporting local tree planting initiatives.

#### 9.2

The maximum number of entries for the event is 90 cars. The Organisers reserve the right to cancel the event if less than 70 entries are received.

### 9.3

The Entry Criteria is as follows:

Only Completed and Paid entries will be accepted. The first 75 entries will be accepted on a first come first served basis, with a further 15 entries accepted at the organisers' discretion. It is a requirement that all parts of your entry application are completed before your entry is considered completed.

# 9.4

Entrants are required to indicate on their Entry Form their eligibility for the various awards and it is the competitor's responsibility to ensure that they are in the correct class.

# 9.5

The order of starting will be at the Organiser's discretion, but to assist seeding, Entrants should note their previous results on the Entry Form. Only the results from the driver's last four rally events should be submitted, along with any other relevant information.

Once the Entry / Seeding List has been published, no communication will be entered into regarding it. Any communication to the Clerk of the Course may result in disqualification from the entry. If there is, however, a safety issue then please send an email to the Entries Secretary outlining your concerns and due consideration will be given.

# 9.6

# **DATA PROTECTION (JERSEY) LAW 2018**

Competitors are hereby notified that by entering the Jersey Rally they are agreeing that information they provide will be stored in a computer retrieval system including those of the organising committee and their delegates and may be used by the Organiser's for organisational and publicity purposes in relation to the event, in compliance with the Data Protection enacted May 2018.

Competitors must note that Data provided by them may be shared with Parish and Police Officials for the purpose of crime and offence prevention. Attention is drawn to Article 17.3.

# 9.7

In order for entry status to be clearly seen by all entrants, there will be 4 categories of entry shown on the ralliesinfo.com entry system, linked to the event website in accordance with H30.1.1:

- a. Accepted or
- b. Pending or
- c. Placed on a reserve list, and position on that list or
- d. Refused

# Note to Jersey Crews:

Jersey Competitors must carry out a job as requested by the Committee. Should a job not be completed we may place the entrant on the reserves list. Any local competitor who has been refused an entry at any level may not be allowed to take a seat in any entered vehicle.

# 9.9

Jersey Rally encourages people to enter online wherever possible. Should it be necessary to post your entry, however, the postal address details are below. Entries must be accompanied by the correct fees and completed accurately including class and previous results to ensure accuracy on the Entry List and assist in correct seeding:

**ALL** entries must be received by either email or posted to the above address, Cash paid entries by prior arrangement. The Organiser's will ONLY be contacting competitors by email. Please make sure that you do supply us with a valid email address.

# 9.10

All entries will be acknowledged within seven days of receipt. The Organiser's will let you know whether your entry has been accepted, refused or decision deferred. D16.1.1. Entries will be accepted at the Organiser's discretion.

# 9.11

Entry fees will be refunded to withdrawn entries as follows, provided we receive confirmation of withdrawn entries in writing to the Entries Secretary.

Prior to the closing date full refund less £100 administration fee.

31/08/24 – 14/09/24 70% refund. 15/09/24 – 24/09/24 60% refund. 25/09/24 – 05/10/24 50% refund.

Competitors who fail to start / do not inform the Organiser's prior to the start of the event forfeit the whole entry fee, competitors placed on a reserves list that do not get an entry will get a full refund.

### 9.12

Should the rally be cancelled, Entrants will be refunded less £100 administrative expenses in accordance with D 29.1.1

The Organiser's reserve the right to refuse any entry. Written acknowledgement of entries received will be emailed to competitors. Accepted entries will be notified by email within seven days of their receipt. Those pending entries will be notified of their status as soon as possible after the closing date.

### 9.14

Entries open on 8 July 2024 and close on 31 August 2024.

# 11. RESULTS

Provisional results will be published as soon as possible (subject to protests) D 26.1.2 of the last vehicle finishing the event or within 7 days by email D 26.1.3 Protests must be made in accordance with C5.1.2. Appeals in accordance with C6.1 & C7.1 Abridged Final Results will be available at the finish venue on the Official Notice Board shortly after the results are declared final as well as  $\underline{\text{www.rallies.info}}$ , and the Jersey Rally website  $\underline{\text{www.jerseyrally.com}}$ .

# 11.1

Competitors shall ensure that they and their cars are available for inspection, should a protest be requested in accordance with C3.2 or C5.2. If the protested vehicle is not available for inspection the competitor may be excluded from the results (Article 20.5).

Results will be published in accordance with H34.1.5

# 12. ROUTE / ROAD BOOK

The event will contain eight special stage venues run a maximum of four times each on closed public roads. Cars will start at 30 second intervals.

Full details of the route and special stages will be given in the Road Book issued to competitors. This document will contain all the necessary information to enable competitors to comply with R2.3.2 & R2.3.3. The Road Book is available in printed form by request to the Entries Secretary by email by 1 September 2024.

Alternative routes will be included in the back of the Road Book, should a stage be unexpectedly cancelled. These will direct you to the next Time Control (Stage Arrival or Service In) along with the time allowance for the route. This should be used to calculate your due time, based on your recorded time of departure from the previous time control.

Cars will be dispatched from MC1, from TC2, from MC3 and from TC4 at 2 cars per minute and all road sections up to the final MC will be run to minute intervals. This is to ensure maximum use of road closures and is for the benefit of all competitors.

Your co-operation in being ready for stage starts and at all other controls will be greatly appreciated.

### 12.1

The event will contain special stages with a mileage of up to 97 miles.

These special stages will be timed to an accuracy of a tenth of a second by use of electronic timing apparatus. If this was to fail then we would revert to hand manual clocks set at BBC time and then timed to a second, as described in R25.7 & R25.8.

Stages will be run on sealed surface roads in the form of closed public roads. Road mileage will be up to 135 miles. Competitors may use fuel stations along road sections which may be marked in the road book.

### 12.2

A set of marked maps using the Digimap Jersey system will define the stage routes. All Organiser's distances will be deemed to be correct. These documents will contain all the necessary information to enable competitors to comply with R2.3.2 and R33.1. For the road sections the Organiser's will provide the competitors with a tulip road book available on Sportity or on any other media advised to the Competitors, including printed copy on email request to the Entries Secretary by 1 September 2024.

# 12.3

The Clerk of the Course can empower officials to search competitors and their vehicles for unauthorised route notes R24.11. Only Patterson's Precautionary Notes are authorised to be used R25.9.

# 12.4

Competitors are reminded of the use of S. O. S. Board / OK boards. R 25.4, and the requirement under R48.10.9 to carry an emergency red warning triangle.

# 13. **SCRUTINEERING & DOCUMENTATION**

At scrutineering cars will be examined for compliance with the 2024 Motorsport UK Tyre, Technical and Safety regulations as well as for class eligibility. Each Entrant and Driver will be assumed to have full knowledge of the car and its eligibility for the class entered. Cars must be presented in the same condition as they intend to compete.

All vehicles will be subject to a full inspection by the scrutineers. At noise test you will be issued with competition numbers and stickers these must be affixed prior to scrutineering.

### 13.1

A validated Motorsport UK Rally Special Stage Vehicle Logbook / Passport and a Category 2 Book where appropriate must be made available at scrutineering, and on demand throughout the event for each car. Vin / Chassis Numbers that do not match up with the Motorsport UK logbook will be retained and returned to the Motorsport UK for verification of Vin Numbers Failure to produce this document may lead to disqualification R 46.3.12. from the results and refused start.

### 13.2

All cars shall have fire extinguishing systems as per 2024 Motorsport UK requirements. K3. to K3.3.3 (inclusive). Small Spill kits must be carried in the car R46.1.5 J5.20.13

## 13.2.1

All competing crews must ensure that their service vehicles are equipped with fire extinguisher/s and spill kits to comply with the Motorsport UK 2024 regulations concerning re-fueling in the service area. Extinguishers must be checked and certified and the certification must be visible to the scrutineers.

#### 13.3

Safety Helmets bearing a Motorsport UK approved sticker will be examined for conformity with current regulations (R) 25.3 and must be worn on Special Stages (R) 25.3.1 Balaclavas must be worn and conform with (R) 25.3.2, (K) 14.3.

# 13.4

Competitors are reminded of regulation R25.3.3 – FHR (Frontal Head Restraint) also called HANS (Head and Neck Support System). The crew must wear FIA approved FHR devices, fitted in accordance with K10.4. and K10.4.1 (requirement for Motorsport UK approval sticker).

# 13.5

Cars shall have fitted, and the Driver and Co-driver shall use seat belts in conformity with (K) 2.1 and (R) 48.10.4. Belt cutters must be carried as per (R) 48.10.11

# 13.6

Drivers and Co-drivers are reminded that they must wear flame-resistant overalls on all Special Stage rallies (K) 9,1, K 9.1.2 & K9.1.5 to K 9.3 R25.3.2

# 13.7

All competitors must have completed scrutineering and documentation by **22:30 on** Thursday 11th October 2024 unless express written authorisation has been provided by the Chief Scrutineer.

All vehicles shall be required to comply with the mandatory noise level of 100dB (A) at tests carried out in accordance with (R) 4.1 to 4.1.3. (Inclusive). All vehicles will be subject to additional tests should the Organiser's consider there is excessive noise. Any vehicle wishing to run anti-lag should ensure that it is switched on during noise test.

#### **14.** TYRES

- 14.1 During the event all crews must complete and maintain the Motorsport UK Tyre Declaration form which will be included in the and documentation provided at signing-on. The Declaration Form must be submitted to the Organiser's/CLO on conclusion of the event or upon retirement.
- 14.2 In accordance with R 48.5.11 the maximum number allowed will not exceed 12 tyres for the first 45 planned competitive miles. An additional 2 tyres may be added for each return to service after 45 planned competitive miles during the event, but these may not be used prior to the relevant service point.
- 14.3 In the event of an extreme weather event (defined as: Temperatures over 28c for a 24hour period), the Clerk of the Course may request the Motorsport UK Steward to suspend the tyre allowance on the grounds of safety.
- 14.4 Where there is significantly heavy rainfall and the Clerk of the Course issues a Bulletin declaring a 'wet' event, the use of wet tyres will be permitted outside of the specified allowance on the grounds of safety.

# 15 **TRACKING SYSTEM**

All competition cars will have to be fitted with a tracking system. The cradle & tracker will be supplied for you by Sport Traxx however if you have the cradle from last year, please do ensure this is fitted. The Tracker will be supplied and fitted at RJA&HS before/at. It is your responsibility to make sure that the Tracker is returned to Sport Traxx at RJA&HS after you finish the event or you retire, failure to do so will incur penalties.

# 15.1

Installation and Operating Instructions will be provided with the Final Instructions.

# 15.2

Any crew which is able but fails to comply with any of the above rules provided in accordance with 15.1 above will be reported to the Clerk of the Course who may apply a penalty.

# **16. DAMAGE DECLARATION**

Competitors will be required to complete and sign a Damage Declaration form at the end of each day, this will form the final page of the relevant Time Card Booklet, stating that either they have not been involved in an accident or incident involving damage to private property or injury to persons or animals or alternatively give full details of any such accident or incident where damage or injury has occurred R40.1.3 such information will not incur a penalty, but note that this card must be handed in with final timecard upon finishing the event. Failure to do so will result in the penalty of disqualification being enforced (Article 20.3)

Competitors who retire during the course of the event must return their completed Damage Declaration Form to the Secretary of the meeting within 72 hours of the event or be liable to a £100 fine in accordance with R40.1.4.

# 17. DRIVING STANDARD OBSERVERS/JUDGES OF FACT

Named Judges of Fact, appointed by the Organiser's, will be on duty throughout the rally to observe and report upon any Competitor considered to be in contravention of Regulations R24.7 R24.7.1 R24.7.2 R24.7.3 R24.7.4 R24.7.5 R24.7.6 R24.7.7 R24.7.8 R24.7.10. The named Judges of Fact and the regulations that they will be enforcing will be displayed on the official notice board.

### 17.1

The Chief Scrutineer and Eligibility Scrutineer appointed for the event are Judges of Fact in respect of Vehicle Eligibility.

#### 17.2

The Organiser's may appoint Driving Standards Observers in accordance with (R) 24.8 R 24.8.1 R24.8.2 R24.8.3 (R) 24.9.

# 17.3

Any notified offence by a competitor or by his Service Crew which involves speeding, reckless driving or failing to observe road signs will automatically be considered as a possible contravention of C1.1.4 (any proceeding or act prejudicial to the interest of the Motor Sports Council or of motor sport generally) and C1.1.5. C1.1.9 The Competitor concerned is liable to be penalised in accordance with (R) 24.8.3 and may be called before a Motorsport UK Disciplinary Tribunal.

### 17.4

In accordance with Motorsport UK rule a red flag system will be implemented during the event.

# 17.5

Competitors are reminded of the 2024 Year Book changes in respect of readiness to Start a Stage at Special Stage Arrival Control (R30.2.3)

# 18. CONTROLS AND TIMING

### 18.1

To be classified as finishers, crews must report with their cars at all controls within their permitted maximum lateness (Articles 17.11 and 20.3)

# 18.2

All clocks will be set to British Summer Time, using BBC time signals/satellite time.

Special Stage timing will be by digital clocks. All vehicles will be fitted with electronic devices for vehicle timing purposes. Each Special Stage will have a Bogey Time and a Target time indicated in the Road Book and on the Timecards.

# 18.4

Timing will be to a TENTH of a second and controlled by the Target Timing Regulations inclusive using digital clocks operated by Officials under the control of an appointed Timekeeper.

#### 18.5

Competitors must be ready to start a Special Stage at any Special Stage Arrival Control. They will be allowed a minimum of 3 minutes between stage arrival and the start.

#### 18.6

Control and Stage Signs will conform to R29.1 to R29.6 R30.1

#### 18.7

Timecards will be issued to Competitors solely for their own use as all official time recording will be electronic.

#### 18.8

The rally will consist of Road Sections and Special Stages.

# 18.9

All controls other than Passage Controls (PC's) and Route Checks (RC's) will be Time Controls (TC's). Each Road Section will be allotted a Target Time based on approximately 20mph average or less, and a Competitor can calculate their Due Time of arrival at any T.C. by adding this Target Time to their actual time of departure from the preceding T.C.

#### 18.10

All Special Stages will have a Bogey Time set at 75mph and a Target Time of 30mph or just under. Competitors will receive penalties on Special Stages as follows:

- Under Bogey Bogey Time
- Over Bogey under Target Actual Time Taken
- Over Target Target Time

Time in excess of Target Time on a Special Stage will count towards the competitor's Cumulative Lateness.

# 18.11

Lateness in excess of Target Time on Road Sections and Special Stages is cumulative. Once a competitor's Cumulative Lateness, calculated from the previous Main Time Control, exceeds the penalty free maximum of 15 minutes a competitor will be disqualified at the discretion of the Clerk of the Course from the results. (Article 21.3).

Should any recorded time not be legible, or not appear authentic, the Organiser's may use any means at their disposal to establish a time.

#### 18.13

The following shall describe the various types of Time Controls in accordance with the Motorsport UK Blue Book R11.5, R11.5.1, R11.5.2 & R11.5.3.

# (a) Main Time Control (MTC)

In accordance with Motorsport UK Blue Book R11.6, R11.6.1, R11.6.2, R11.6.3, R11.7..

The Jersey Rally will operate Main Time Controls (MTC) at the beginning of Friday's rallying and at the end of Friday evening's rallying, and again on Saturday Morning concluding with an MTC at the conclusion of Saturday afternoon, everything else will be a Time Control (TC).

A competitor who is early at an MTC (IN) may wait for their Due Time outside the Control.

At an MTC (OUT) & TC, Competitors will restart at designated intervals either in number order or in order of their arrival at the MTC (IN), or as may be specified in an Official bulletin.

Each Competitor shall be given a due starting time from any MTC (OUT) & TC. The difference between this time and their actual starting time will be counted towards exclusion for cumulative lateness. Also, a time penalty will be applied.

Competitors arriving at any MTC (IN) within their maximum permitted lateness will, subject to the above, restart from any MTC (OUT) with Zero lateness, i.e. lateness is accumulated only between two successive MTC's.

# (b) Special Stage Arrival Control (SSA)

At this control the competitor will be given their time of arrival and will have a minimum of 3 minutes after the arrival time. The area between the SSA Control and the SSS is Parc Ferme as per R31.2.11.

# (c) Special Stage Start Control (SSS)

At the SSS a competitor will be given a Start Time for the Stage in hours and minutes, and seconds. Failure to be ready after time allowed will be penalised in accordance with R 32.2 (d) and R 32.13 (e). Any crew refusing to start will be penalised as R 25.8.2. The start will be signalled by traffic lights which will go from RED (15 seconds to go) through AMBER (5 4 3 2 1) to GREEN at the start time. Electronic beams will be used to determine a jump start. No Verbal 30 second warnings will be given.

# (d) Special Stage Finish Control (SSF)

At the SSF a competitor will be given their Finish Time in hours, minutes, seconds and 10ths. This time in hours and minutes constitutes Start Time for the following Road Section.

Any Competitor who fails to stop at the Stop line must return to the SSF on foot, reversing the car is prohibited, subject to a penalty of disqualification R 32.2(p).

# (e) Service Control (SV)

All Service Areas will have IN and OUT Time Controls. At Service Areas not designated as MC's a Target Time will be specified between these controls. The Section between SV (IN) and SV (OUT) will be marked as a Road Section.

# (f) Passage Control (PC)

At any point indicated in the Road Book, the Organisers may establish a PC in order to collect Time Cards from Competitors or for other purposes. A Competitor failing to provide the necessary documents at any PC will be deemed not to have reported there and will be disqualified, Article 17.1 & 17.7.

Any times recorded at a PC will be used only to ensure that Competitors have followed the requirements of the Road Book, and not to calculate Cumulative Lateness

All Controls will open 15 minutes before the Due Time of Car "0" and close 16 minutes after the Due Time of the last Competitor still running, having taken into account any delays. Regrouping controls will/may be established along the route and will be subject to the rules governing Time Controls. The purpose of these regroupings will be to reduce intervals, which may occur as a result of late arrivals or retirements. The time of restarting from the regrouping control will not be determined by the duration of the halt, and therefore the first car will restart at the scheduled time and other cars at one minute, or 30-second intervals according to the basis of the road timing for that leg of the event. Crews will receive instructions as to their restarting times on arrival at the regrouping control. They must immediately park their cars as instructed in the parking area where Parc Ferme regulations will apply (Article 19). Crews must remain with their cars in this area.

# 19. ROUTE NOTES

In accordance with R24.12 Route Notes may be used for the routes as laid down. Route Notes will be available from Patterson Notes two weeks before the start date. Only notes supplied by Patterson's are acceptable for use. Personal notes are strictly forbidden –R32.2Q . This does not however preclude competitors from making notations thereon to suit each competitive crew's own styles. All notes NOT supplied by Patterson's, photocopied or notes copied in any way will incur penalties. In all instances competitors are advised that the organisers accept no liability or responsibility in the use of the Route Notes.

# 19.1

Practicing is forbidden. If a competitor is found practicing on the stages as published, or any road that may be used for this event, they may be disqualified from the event (Article 20.3 and Article 20.5)

# 19.2

The organisers request that all competitors aim to complete only three reconnaissance runs through each stage in order to respect the Island residents on all routes. It is recommended that competitors purchase the download/DVD of the stages with the notes which can then be used to "recce" at home.

#### 19.3

Recceing is forbidden for all competitors after 14.30 on Thursday 11<sup>th</sup> October (It is requested that local Driver's / Navigators refrain from recceing on the Thursday) and during the hours of dusk till dawn at any time in 2024. Any vehicle used, must be as the manufacture supplied, no vehicle will have **ANY** type of safety device fitted I.E. Roll cage, Racing seats, Voice headsets Safety guards to the underside of the vehicle.

All competitors **MUST** obey all Jersey road traffic laws and speed limits, failure to obey the laws of Jersey will incur a penalty. (Article 20.3 & Article 20.4).

#### 19.4

Reference is made to R29.6.8 – prior to reconnaissance, chicanes will be marked on the road to be easily visible in wet weather conditions (white to be the preferred colour). Events are to use a stencil that mirrors the size of the element where safe to do so. A board 100m prior to the location and/or a sign identifying the first element and the side of the road of entry should also be in position. Please also refer to R29.6 regarding construction and design of chicanes.

# 20. SERVICING

Servicing is defined as in R38.1.1, R38.1.2 R38.1.3 R38.2 Persons travelling in a Service Vehicle are "Service Crew".

#### 20.1

<u>Refuelling</u> will be allowed in service areas subject to the terms and conditions outlined in Annex Q of the Motorsport UK Rally Future document under the heading "Self-Refuel".

Refuelling should be the last operation to be carried out before the vehicles leave. The vehicle should be off any support stands, have all four wheels on the ground, have all other work ceased and have no occupants, when re-fueling commences. All sources of ignition must be removed from the area and an appropriate fire response should be prepared.

All vehicle re-fueling is to take place in the open air. Smoking and any other sources of ignition, including live electrical items, must be prohibited and a safe area should be enforced with an operative on standby with a fire extinguisher.

Refueling operatives, including those standing by with fire extinguishers, should ensure they are wearing protective clothing, including gloves and eye protection.

Penalties for breach of re-fueling guidelines are defined in chart 32.2(t).

### 20.2

Barbeques, gas cookers open fires or any other naked flames are banned in Service Areas (Article 21.3).

# 20.3

There will be One Service Area throughout the rally. All personnel must be off the premises by 23.00 on each day of the event, failure to comply with this instruction may be penalised with disqualification.

# PARC FERME WILL EXIST FROM 23.01 to service open times (see Article 5)

These will only be accessible to Competitors and Service Vehicles bearing Official Plates. No other areas may be used by Service Vehicles, which are required to follow a prescribed route to the Service Areas. All other areas will be Out of Bounds to Service Crews and Vehicles.

Competitors may work unassisted on their own cars using equipment carried in their car in "No Service Areas", except:

- Within 100 metres of any Control R38.2
- Between Special Stage Arrival and Special Stage Start, Controls, and in any Parc-Ferme.

The only work permitted in these areas is, to carry out the following unassisted: Cleaning lamp glasses, windscreens, windows, identification markings and vehicle registration number.

# 20.5

Servicing in designated Service Areas <u>must be carried out on ground sheets</u> at RJA & HS Service Area ensuring that support by wood or other material suitable to spread the weight under jacks and stands is used. Please take care with the environmental impact of our use of the service area and ensure that all waste is swept up into bins. Spill kits are to be used where necessary and disposed of in the designated bins in the Service Area

### 20.6

Service Crews are subject to the same regulations as competitors regarding noise, bad driving manners, etc. Officials and Marshals have been instructed to note any infringements of these rules (Article 17).

# 20.7

Competitors are responsible for ensuring that their Service Crews understand and comply with these regulations and that their Service Vehicles bear an Official Plate showing the competitor's rally number, this plate must be fixed to the front of each Service Vehicle and clearly visible at all times.

### 20.8

A Competitor receiving assistance contrary to these SR's may be penalised in accordance with R38.1.2. Any Competitor whose Service Vehicle is observed in an Out of Bounds area may be penalised by disqualification at the discretion of the Clerk of the Course (Article 21.3).

# 20.9

The use of "chase cars" or "management vehicles" is prohibited due to the nature of the Island roads and the P.R. sensitivity of the event. Any crew who is observed to have, in the eyes of the Organisers and their Judges of Fact, operated such a vehicle, whether or not assistance is actually received from such a vehicle may be disqualified at the discretion of the Clerk of the Course as if outside assistance had been provided as in Article 20.8.

# 21. PENALTIES

Competitors will start with zero penalties. Classification for the results will be determined by the total time penalties. The winner being the Competitor with the least total time including penalties (Article 18).

# 21.1

In the event of a tie the winner will be the competitor who has completed the greatest distance from the Start with the least Penalties.

The penalties in R32.2 apply as written unless specifically modified in these SR's.

#### 21.3

Contravention of the following carry a penalty of disqualification at the discretion of the Clerk of the Course: SR Article 8.3, 13, 13.2, 13.3, 13.4, 13.5, 16, 18.1, 18.11, 18.13(d), 19.1, 19.2, 20.2, 20.6, 20.8, 20.9, 21.7, 21.8. The discretion of the Clerk of the Course is not limited to the contravention of these Articles and the contravention of any Article or Regulation may result in disqualification.

### 21.4

Contravention of the following may lead to refused start: SR Article 8.3, 13.1, 13.2, 13.3, 13.8, 19.2.

\*The Clerk of the Course may report a Competitor so penalised to the Stewards of the Meeting and/or the Motorsport UK for further disciplinary action.

#### 21.5

Contravention of the following may lead to disqualification from the results at the discretion of the Clerk of the Course: (a) SR Article 11.1, 13.1, 13.2, 19.1.

Causing a decibel meter reading of greater than the specified limits will be deemed excessive noise.

- (b) This will be measured in accordance with a test, specification details in the Motorsport UK General Regulations. It is at the discretion of a Judge, Noise Test Official or Driving Standards Observer, or of the Organisers, whether a car which causes excessive noise is refused permission to proceed at any time.
- (c) A Driving Standards Observer's decision on imposing a penalty for excess speed or bringing the sport into disrepute shall also be reported to the Stewards of the meeting.

### 21.6

Competitors are reminded of the details of computation of penalties in the event that the normal running of a stage should be stopped. Should any Special Stage be cancelled during the event or deleted from the results after the event, only the Stage penalties will be deleted. Unless an Official Bulletin has been issued to the Contrary, the cancelled stage must be traversed within Target Time, and will in every other respect be treated as a Road Section. In accordance with Motorsport UK Blue Book R24.5, R24.5.1 & R24.5.2. This is the section relating to receiving nominal times due to the stage having to be stopped or paused.

# 21.7

Causing an obstruction on an access road to or from a Special stage could be penalised by disqualification at the discretion of the Clerk of the Course. (Article 21.3).

# 21.8

Failure to attend Post-Event Scrutiny for those Competitors selected, within the time limit specified, may result in disqualification at the discretion of the Clerk of the Course (Article 21.3).

Awards will be finalised after the results have been declared final, and will be presented at the Merton Hotel after the event dinner as follows:

# **23 INSURANCE**

The Entrant is required to supply the name and address of their insurers on the entry form. As many insurance policies no longer give cover for competition REIS Insurance will be able to provide Competitors who need to use the scheme with the Third Party Cover necessary to meet the requirements under Article 50 of the Road Works and Events (Jersey) Law 2016 on the road sections of the event.

In the event of a claim having to be made for damage caused to a third party property by a competitor, the organisers and promoters of the event reserve the right to pass on the insurance excess under the Motorsport UK Master Policy (currently £450.00) to the competitor(s) involved. 6.4. For damage to uninsured items like Armco barrier the competitor will be liable for the cost of any claim.

# New applicants wishing to use the scheme must be able to comply with all points of the Marsh Insurance cover Declaration below:

Is aged 19 years or over

Has held a full driving licence for a minimum of 6 months

Has no more than six points on their licence

Has had more more than one fault claim in the last three years

Is a named driver on a valid motor insurance policy for the vehicle they are driving

Do not have the third party extension cover on their existing motor policy

The vehicle has a valid MOT and taxed for the road, unless exempt from doing so

# If you are able to comply with all of the REIS Insurance points above:

Simply sign the required forms at signing on, for insurance and pay the required premium.

If you are not able to comply with the above requirements, please contact the General Secretary of the Jersey Motorcycle and Light Car Club by email on <a href="mailto:secretary@jerseymotorsport.com">secretary@jerseymotorsport.com</a> to discuss whether arrangements can be made. This must be completed no less than one week before the event.

# 23.1

Entrants intending to use their own insurers must carry a valid insurance certificate or cover note specifically endorsed to provide cover during the road sections of a special stage rally. The Organisers will not enter into any contact with insurance companies or brokers in this regard.

### **24 BREAKDOWN**

Please note that in the event of an incident or breakdown, your vehicle will be towed to a safe area. This will not necessarily be the service venue and you will be responsible for thereafter arranging for the recovery. Preferential rates have been arranged with a local breakdown services and numbers will be made available to all competitors in the finals.

# **25.TRAVEL AND ACCOMMODATION**

We recommend that you await acceptance of entry before you finalise your travel arrangements and accommodation bookings.

# SUPPLEMENTARY REGULATIONS

These supplementary regulations are an extension of the supplementary regulations for the Roberts Garages Jersey Rally 2024 to be held on 12th October 2024 (hereinafter known as the Roberts Garages Jersey Rally).

# 1.1

Only entrants/Competitor/s that were signed on and issued with the relevant documentation for the Roberts Garages Jersey Rally will be accepted into the Trophy Rally.

# 1.2

The Trophy Rally is to be run on 12th October 2024. Individual start times will be issued at RJA & HS from 07.00.

# 1.3

All vehicles that wish to enter the Trophy Rally must be re-scrutineered. Scrutineering will be at RJA & HS at 07.00. A new scrutineering sheet will be issued by the Scrutineers and must be completed and handed in to the Event Secretary. Only the original Vehicle and Driver / Navigator entered will be accepted.

All documentation as issued at signing on for the Jersey Rally is to be used for the Trophy Rally, so when wishing to be accepted for the Trophy Rally you must bring it with you to be re stamped. There will be an administration Fee of £20.00.

### 1.5

You will be issued with letter "T"s once accepted for the Trophy Rally and these are to be fixed next to the number on the doorplates and at the top, nearside, of the front and rear windscreens. Failure to fit them will mean you may be penalized.

### 1.6

No monies paid, once Signed On or having started the Jersey Rally and or the Trophy Rally are refundable.

### 1.7

The organisers of the Jersey Rally have the right if necessary, to withdraw and or hold back Trophy Rally competitors at any time, due to event timing or road closures. The winner of the Trophy Rally will be the person who has covered all the stages up to being withdrawn by the organisers as per Jersey Rally SR's 15 to 15.13 (a) to (f).

### 1.8

Trophy Rally competitors will be placed in the running order according to the agreement of the Motorsport UK Steward and Safety Delegate and the Clerk of the Course.

### 1.9

Two Awards will be awarded to the winner of the Trophy Rally. There are no other awards.

# 2.0

Competitors who have been disqualified from the main event as a result of disciplinary procedures will not be allowed to compete in the Trophy Rally.
